

FLORABRITAIN DESIGN A LOGO COMPETITION

TERMS AND CONDITIONS

1. The prize draw (the "Prize Draw") is open to people aged 18 and over who are professional retail florists or work for a professional florist.
2. Winners may be asked to verify which flower business they work for or own, and FloriSmart may undertake to verify that they meet the criteria to qualify as a professional retail florist.
3. To qualify as a professional retail florists, the entrant must have at least one or more of the following – a bricks and mortar premises where they pay business rates tax, be registered for VAT, have a business bank account for their florist transactions, be a member of the Good Florist Guide. The decision of an entrant's eligibility for the competition will be taken by FloriSmart at their discretion and will be final.
4. Core team members and consultants of FloriSmart UK Ltd, The Florist Magazine or any of the sponsor or organisers, or anyone else connected with the Prize Draw, may not enter the Prize Draw.
5. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.
6. To enter the Prize Draw you must submit your original artwork designed logo for Flora Britain, a company offering British grown flowers to retail florists. 7. The winning entrant accepts that their logo may be used by Flora Britain at its discretion, including, but not restricted to, use on their website, packaging, newsletters, business cards, marketing literature and objects. The winning entrant receives their prize upon signing an agreement to give up all rights to their logo to Flora Britain.
8. FloriSmart accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by FloriSmart.
9. The closing date of the Prize Draw is 23:59 on the 24th April 2015. Entries received outside this time period will not be considered. Entries need to be emailed to competition@florabritain.co.uk

10. Three finalists will be chosen from the entries received in accordance with these Terms and Conditions. The winner will be chosen by the steering committee members of Flora Britain, with the assistance of FloriSmart UK Ltd and The Florist Magazine. The decision will be made by 27th April 2015.
11. The three final entries will be posted onto The Florist Magazine's Facebook page whose members will be invited to vote on the winning entry. The votes will be counted on Friday 1st May and the winner announced on the Florist website.
12. If the steering committee do not believe that any of the submitted logos are appropriate to represent Flora Britain, then it reserves the right not to appoint finalists or a winner.
13. The winner will receive £1000 worth of flowers from Flora Britain, to be ordered through FloriSmart in a maximum of 5 orders with a minimum of £200 per order. All orders must be placed before 30th September 2015 or the £1000 voucher will have been deemed to have expired.
14. Any flowers bought in excess of the £1000 on the final order will be invoiced to the winning florist.
15. The winner will be notified by email on or before 5th May and must agree in writing to allow Flora Britain to use the logo for whatever purpose at its own discretion. If a winner does not agree these conditions within 14 days of being notified by FloriSmart UK Ltd, then the winner's prize will be forfeited and FloriSmart UK Ltd shall be entitled to select another winner in accordance with the process described above (and that winner will have to agree the conditions within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and FloriSmart UK Ltd shall be entitled to select another winner.
16. The prize voucher will be issued by email to the winning florist, and will entitle the florist to order flowers through the Flora Britain webshop at www.florismart.com as outlined in the clause 13.
17. The name and business name of the winner will be announced in the Florist magazine, and the winner consents to be revealed in the Florist magazine in an announcement or article at the discretion of the florist magazine.
18. The prize is non-exchangeable, non-transferable, and is not redeemable for cash or other prizes.

19. FloriSmart UK Ltd retains the right to substitute the prize with another prize of similar value in the event the original prize offered is not available.
20. By entering the Prize Draw, you agree to the collection, retention, and usage of your personal information in order to process and contact you about your Prize Draw entry.
21. FloriSmart UK Ltd accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Prize Draw or accepting the prize. FloriSmart UK Ltd further disclaims liability for any injury or damage to your or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the Prize Draw.

FloriSmart UK Ltd reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Draw with or without prior notice due to reasons outside its control (including, without limitation, in the case of anticipated, suspected or actual fraud). Such circumstances shall include, but not be limited to, weather conditions, fire, flood, hurricane, strike, industrial dispute, war, hostilities, political unrest, riots, civil commotion, inevitable accidents, supervening legislation or any other circumstances amounting to force majeure.
24. The Prize Draw will be governed by the laws of England and Wales and entrants to the Prize Draw submit to the exclusive jurisdiction of the English courts.
